CALL TO ORDER

Mrs. Reynolds, Chairperson, called the meeting to order at 7 pm and welcomed everyone. The meeting opened with the Pledge of Allegiance.

PUBLIC HEARING ON FISCAL YEAR 2017 BUDGET

Pursuant to Massachusetts General Laws, Chapter 71, Section 38N, notice of the public hearing on the fiscal year 2017 Budget was published in the Gardner News (2/22/16); the Sentinel & Enterprise, Fitchburg (2/19/16); and the Telegram & Gazette, Worcester (2/20/16). The meeting notice was emailed to all city/town clerks in the District for posting and was posted on the Monty Tech Website.

Copies of the Monty Tech Tentative Budget 2016-2017, Public Hearing, March 2, 2016, were distributed to those present and will be sent to all the cities and towns in the District.

Mrs. Tammy Crockett, Business Manager, presented a PowerPoint explaining the budget process, the Foundation Budget, net school spending, minimum contribution and gave an explanation of how a community's assessment is calculated. She presented individual information to all the city and town representatives regarding their assessments.

Mrs. Reynolds asked if there were any representatives from the cities and towns of the District present. Mr. Leroy Clark, Fitchburg, was present but did not speak.

School Committee members thanked Mrs. Crockett for the complete and informative presentation of the FY2016-2017 tentative Budget.

Mrs. Reynolds closed the Public Hearing at 7:55 pm.

APPROVAL OF MINUTESRegular Meeting – February 3, 2016Mrs. Swenson moved to approve the minutes of the regular meeting ofFebruary 3, 2016 as presented.Seconded by Mr. Commodore.Vote – so voted.Mrs. Reynolds abstained from voting.

SUPERINTENDENT-DIRECTOR'S REPORT

Approval of Out-of-State Field Trip for JROTC Students

Mr. Capone moved that the District Committee approve the overnight out-of-state field trip to Aston, PA, requested by JROTC to compete in the Region One Youth Physical Fitness Meet from March 18 through March 29, 2016. Seconded by Mrs. Barclay. Vote – so voted. Mrs. Reynolds abstained from voting.

Monty Tech Vet Tech Program Update

Superintendent Harrity gave a PowerPoint presentation updating the Monty Tech Vet Tech Program. Phase I is the design and construction costs and total projected cost is \$1,016,317 and as of March 2, 2016, \$817,201 has been committed for total support/program match.

Phase II is the equipment, supplies and materials needed for the project. Total projected cost is \$502,797 of which \$446,293 has been committed or is pending.

Total projected cost for Phase III, Staffing, is \$358,100 of which \$250,000 has been committed.

Report from the Designer Selection Committee

The Designer Selection Committee for the Vet Tech Project met on February 12, 2016 and a record of the meeting was presented for information. On February 17, 2016, the top three design firms were interviewed and Lamoureux Pagano Associates was chosen to enter into fee negotiations with the Superintendent-Director.

Approval of Designer Services Provider

Mrs. Swenson moved that the District Committee award the contract for the designer services for the Montachusett Regional Vocational Technical School Veterinary Science Training Program building, based on the recommendation of the Designer Services Selection Committee, to Lamoureux Pagano Associates for a fee of \$47,500 for pre-design/programming and design.

Seconded by Mrs. Barclay.

Vote – so voted.

Mrs. Reynolds abstained from voting.

Superintendent's Update

Superintendent Harrity presented a written report of her activities in February. She welcomed Mr. Tom Kingston, her coach, to the meeting.

- Technology: Conducted interviews for the next Technology Director. Met with Technology AdHoc committee working on the selection of the Chromebook device.
- National: Attended the District Administrator Leadership Institute (DALI) Superintendent's Summit in Scottsdale, Arizona. Monty Tech's Vet Tech Program will be featured in their national publication in March.
- District: The Sheriff's inmates crew painted the Plumbing Dept. Bert Jacob, "Life Is Good" founder, is scheduled to speak on March 4, 2016. Each student has received a Life Is Good tee shirt.
- State: The Department of Elementary and Secondary Education (DESE) has asked Superintendent Harrity to serve on the NSFY State Team to steward the goals of the initiative to increase the number of students who are to compete for high-skill jobs. This is a grant opportunity for states.

- Community: Met with the WPI President to discuss school-education partnership, attended the Fitchburg Planning Meeting, attended the Worcester County Superintendent's meeting and met with a trustee of the Hanson Trust and received a donation of five \$1,000 scholarships and a \$2,000 donation to the Electrical Program.
- Business: Met with Edward Manzi, CEO Fidelity Bank, to develop schoolbusiness partnership. They are interested in taking students on co-op.
- Career Readiness: Attended the Program Advisory meeting. There are 50 new members. The meeting featured capital equipment purchases and shop upgrades made in the last five years.

Enrollment Quota for the Class of 2020

Mrs. Swenson moved that the District Committee approve setting the enrollment quota for the Class of 2020 at 360 students and to authorize the Dean of Admissions to accept up to 375 students after June 1, 2016.

Mr. Boone, Mr. Capone, Mr. Gould, and Mrs. Holbert voted no. Mrs. Reynolds abstained from voting.

As requested, the Admission Policy will be on the Agenda for the April School Committee meeting.
